Part I: Rule Updates/Progress

1. Groundwater Protection Rule and Strategy: Still in the subgroup getting revisions. The major discussion points continue to be the presumption of compliance for wastewater and storm water. Those programs are currently preparing demonstrations on the applicability of the presumption to their permitting programs.
2. Investigation and Remediation of Contaminated Properties (IROCP): Comments due on preliminary draft rule today (2/12). The timing of rules moving through the comment period – IROCP aiming for completion of rule making process by July (per development soils statute requirement); ideally the GWPRS would work through the process first such that the IROCP can reflect it appropriately.

Part II: Survey Results and Brainstorming

The results of the circulated ‘survey’ are below. The plan is for these ideas and discussion items to guide the GWCC meetings over this next year and to be incorporated into a guiding groundwater management plan.
