c. Issuing public notice to the Consecutive Water System's users if a violation of a drinking water contaminant standard exists or if the ANR secretary determines that a condition exists that may present a risk to public health.	
(c) The Wholesale Water System has included a written description of the changes to its sampling plan with this application for review and approval by the Drinking Water and Groundwater Protection Division.

## INSTRUCTIONS FOR CONSECUTIVE APPLICANT AND WHOLESALE WATER SYSTEM

- **SECTION A to be completed by the Consecutive (receiving) Public Water System** applying for exempt status 1. Applicant - The applicant must be the owner of the water system. An owner is the individual or entity that is legally and financially responsible for the water system. An owner may be a municipality, fire district, homeowner's association or similar entity, or may be an individual.
- 2. List the name of the Consecutive Water System and WSID #.
- 3. Exemption criteria To qualify for the exemption, the consecutive water system must meet all of the criteria in this section. The definition of selling for purposes of this law and subdivision 203(3) of Title 30 Public Service, a "sale" of water does not occur when:
  - a. the rate charged to the consumer by the receiving water system is the same as the rate charged by the public water system for supplying water to the receiving water system; and
  - b. the receiving water system follows the uniform water and sewer disconnect requirements of chapter 129 of Title 24, (Municipal and County Government disconnection revisions); except that section 5147 of Title 24 shall not apply and appeals shall be governed by the Vermont Rules of Civil Procedure.
- 4. Signature –Section A of the application must be signed by the owner of the consecutive water system applying for exempt status to certify that the consecutive system meets the exemption criteria

## SECTION B - is to be completed by the Wholesale (supplies water) Public Water System

- 1. List name of wholesale public water system, WSID number and owner
- 2. (a) For the Consecutive System to qualify for the exemption, the Wholesale Water System must certify that the Consecutive System has responsibility for maintenance and repair of the consecutive system unless otherwise agreed to by the wholesale and consecutive systems.

(b) The wholesale systems must include the Consecutive Water System in its water quality sampling plans (if they do not already) for contaminants including total coliform bacteria, lead and copper (any Tier 1 or 2 sites), and disinfection by-products (DBPs). This does not mean the wholesale system must sample for all of these contaminants in the consecutive system, but needs to include the consecutive system in its overall sampling plans. For example, the wholesale system may include a total coliform bacteriological sample periodically from the consecutive system, must include any Tier 1 or 2 sites under the lead and copper rule, and may need to change their sampling location for DBPs if the consecutive system represents a maximum residence time location. The wholesale system needs to submit in writing that they have considered the consecutive system in its sampling plans and include any proposed changes to its sampling plans which will be reviewed and approved by Drinking Water and Groundwater Protection Division staff.

- 3. Signature Section B of the application must be signed by the owner of the Wholesale Water System supplying water to the Consecutive System.
