Re: Well Driller End of Year Report for 2014

Dear Driller,

I have attached the Well Driller End of Year Report for 2014 and the current list of licensed drillers. As we now begin revisions to the Water Supply Rule (chapter 21) for public water systems, I am still interested in getting your comments, suggestions, and technical expertise as we revise the Well Construction and Isolation Standards in Appendix A, Parts 11 and 12. Permits are required for all water systems, both public and private. The current rules need to be changed to reflect the new category of Potable Water Systems (formerly the Small Scale Water Systems) and to update the construction standards for not only drilled wells (new technologies, expanded grouting options, update isolation distances, etc.) but also for springs, shallow water sources, etc. Please send your written comments to me at the above address.

The licensing renewal period was completed in the summer of 2014. Thank you for your prompt response on filing your renewal applications as that helped the process occur smoothly. Fill in fields such as Town, Owners last name, Well Driller Name, Well Tag Number, etc. and the program will search for the well log information. This report can be printed. The program also lets you call up well logs by Town to get a list you can browse.

Related Rule Revisions in 2014

The current Water Supply Rule (Chapter 21) and the Wastewater System and Potable Water Supply Rule (Chapter 1) were in the process of having changes drafted to reflect the new category of Potable Water Systems (formerly the Small Scale Water Systems) and to update the construction standards. This includes not only drilled wells (new technologies, expanded grouting options, update isolation distances, etc.) but also for springs, shallow water sources, etc. Revisions to the Well Driller Construction Standards were reviewed and updated by the DEC Technical Advisory Committee which is made up of state staff, engineering and hydrogeology consultants, well drillers, and site technicians. Universal jurisdiction is in effect and either water/wastewater permits or source permits are needed for all new private and public drinking water sources. Check with the Vermont ANR Regional Office near your project for assistance.
