

## State of Vermont PERMIT AND LICENSE INFORMATION

## LODGING ESTABLISHMENT LICENSE

SUMMARY DESCRIPTION OF PERMIT	This is a license which a person, partnership, or corporation must obtain before they are allowed to operate an establishment which provides lodging to the public.
CRITERIA FOR JURISDICTION	Any lodging establishment with three or more units that caters to the traveling and transient public, and advertises that they have lodging, by the night or weekend. This includes bed and breakfasts, inns, motels, hotels and lodges.
INFORMATION REQUIRED	The application requests information about the licensee the type and capacity of the facility being licensed, type of water and sewage systems serving the facility, proposed opening date, and public building permit status. Applications also require a tax and child support statement.
