

TO APPLY FOR A NEW PERMIT

CORPORATIONS – “I encourage you to do this first, before you fill out the applications”.

If you are seeking to do business in Vermont as a business name other than your own personal name, or if your business is an out-of-state “foreign” corporation, you are required to register with the Vermont Secretary of State’s Corporation Division, prior to applying for a permit. It is up to the hauler to periodically review the Corporation’s Division’s website to assure registration is active during the duration of the permit. SOLE PROPRIETORSHIP – If you are not a corporation, and are the only owner, you should list your business as “doing business as” (dba) on all applications. Example: John Smith dba John Smith’s Trucking.

PERMIT INFORMATION

YOU WILL NEED A VT WASTE TRANSPORTER PERMIT IF:

- You transport regulated quantities of hazardous waste; or
- You transport solid waste (includes liquids) or residual waste for compensation.

As required by your permit, submit your applications listed in the next column for a **New Permit, or Renewal of your 5 -year Permit.** **Permit renewals are due by May**

1, 2018. The only exemption is if the waste transportation services are incidental to other non-waste services offered, and less than 4 cubic yards of solid waste is transported at any time. To comply, immediately submit the applications located in the next column. You can download these applications from the following link:

Please include a check with the applications. Checks should be made out to: **State of Vermont, Treasurer.**

Don't risk a fine, Apply on-time!

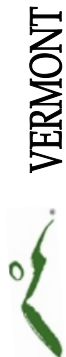
WHAT DO I NEED TO SUBMIT FOR A NEW PERMIT, OR PERMIT RENEWAL?

- ✓ **INCOMPLETE APPLICATIONS MAY RESULT IN DELAY, OR DENIAL OF YOUR PERMIT.** Please make sure all applications are, signed & dated, notarized, all boxes are checked, all questions are answered. Please read all applications carefully, and if you have any questions, contact me.
- ✓ **ARE YOU HAULING WITHOUT A PERMIT?** If so, please contact me immediately for applications for a new permit. The cost of the permit is far less than the cost of fines.
- ✓ **NO LONGER HAULING?** Let us know and we will remove you from our mailing list.
