# Aquatic Nuisance Control Study Committee Meeting Pursuant to Act 57 of 2023

September 29, 2023 8:30 am – 10:30 am

#### **MEETING MINUTES**

- 1. Meeting Minutes September 18, 2023
  A motion was Dr. William Bress made by and seconded by Amy Sheldon, all were in favor, to accept the September 18, 2023 Meeting Minutes.
- 2. Administrative Tasks
  Approval provided to record the meetings.
- 3. Overview of Act 57 of 2023 An Act Relating to Aquatic Nuisance Control
  - a. Presentation of ANC Permits and History of Pesticide Use in Vermont available on Act 57 (2023) Aquatic Nuisance Control Study Committee webpage. A review of the historical use of pesticides in Vermont from 2000-2023, and a review of the ANC Statute 10 V.S.A. § 1455 Permit Criteria and the application of these criteria used by DEC.
    - o Question on whether there is build up within fish tissue of Procellacor. A follow-up review from the EPA will be provided regarding this.
    - o Question regarding whether PFAS were present as an ingredient in Procellacor. A follow-up inquiry to the VT Agency of Agriculture about what they may have learned about PFAS residuals in pesticides will be completed.
    - o Question on how the Agency of Agriculture works with DEC to review pesticide permits and applications, especially where crops may be affected. An Agency of Agriculture inspector is present during the treatments to ensure that safety and precautionary measures are met but are not involved in the Internal ANC Internal Review Procedure to review individual permits. The Agency of Agriculture is on the Agricultural Innovation Board (AIB).
  - b. Overview of ANC Pre-Rulemaking Group
    Specific work was completed for and by the ANC Pre-Rulemaking Group that is applicable and informational for this Committee. It is recommended to review the

c. Overview of ANC Individual Permit Application Internal Review Procedure
ANR Internal Review Procedures for the ANC permits were established by the DEC,
FWD, and VDH and signed into agreement in March, 2023. These procedures follow
guidelines for how technical projects partners may comment and advise DEC on ANC
