Project Location: north of the parking lot associated with 256 Grove, Brandon

Project Description: removal and disposal of concrete road, widening and full depth reconstruction of US Route 7, reconstruction of both sides of the road, sidewalks, parking areas, grading, drainage, water, sewer, relocation of aerial and underground utilities, paving, traffic signals, signs, and pavement markings

Wetland Impact: 807sf

Buffer Zone Impact: 1680sf

Expiration Date of Authorization: Five years from issuance of authorization.

FURTHER INFORMATION

An application for authorization under Vermont General Wetland Permit (#3-9025), required pursuant to the provisions of Section 9.7 of the Vermont Wetland Rules has been received by the Vermont Agency of Natural Resources (VANR). The wetland proposed to be impacted has been designated as a significant (Class II) wetland in the Vermont Wetland Rules. 
