

# Aquatic Nuisance Control General Permit

## Registration – Rapid Response Control Activity

Under Chapter 50 of Title 10, § 1455

Submission of this completed Registration constitutes notice that the applicant identified in Section A, who is a registered lake association, requests to be authorized to conduct a nonchemical rapid response control activity in the waters identified in Section C that targets an aquatic plant that is a nonindigenous new aquatic species in the water body using benthic barriers, diver assisted suction harvesting, or a combination of the two, under the [Aquatic Nuisance Control General Permit](#) (ANCGP). To be granted coverage, all information required on this form must be completed and the requisite fees (Section G) must be made payable to the State of Vermont.
