Environmental Careers and Opportunities (ECO) AmeriCorps is an AmeriCorps program within the Vermont Department of Environmental Conservation (VTDEC). The emphasis of the program is on building capacity in nonprofit organizations and municipalities throughout rural Vermont communities. Program focus areas include the following:

- engagement, outreach, and education
- improvement of water quality
- protection and restoration of public lands

ECO AmeriCorps is funded in part by an AmeriCorps state grant provided through SerVermont from the Corporation for National & Community Service.

All ECO AmeriCorps members have some college education (preference given to college graduates with a science background) and will receive technical training and mentorship from VTDEC throughout their term of service. VTDEC handles the administrative components of the program, including providing living stipends, health insurance, and monthly trainings to members.

I have been the Projects Coordinator at FNLC since April 2018. My responsibilities include oversight and management of all grant funded projects, development of new projects, grant writing, andoutreach coordination.

Describe your proposed service position:
With limited paid staff, our organization is seeking the service of an ECO AmeriCorps member to
help build capacity to increase services to the region. This service project will assist the ProjectsCoordinator in providing community education, landowner outreach, project development, implementation oversight, and grant writing assistance This position will also be responsible for collecting water quality samples in the Rock River watershed.

In this position the applicant must be able to perform the following:

Serve independently to meet deadlines and project milestones.

Have or obtain a valid drivers license and reliable automobile to travel to water quality testing sites. Walk up to 1/2 mile through vegetated areas (often in agricultural scenarios) to obtain water samples.

Willingness to "get hands dirty" to help implement small scale green stormwater infrastructure.

Follow written protocols.

Be a self-motivated critical thinker.

Willing to serve with school aged children.

Desired qualifications:

FNLC is seeking an ECO AmeriCorps member with a bachelor's degree, or background in biology, natural resources, environmental studies, or environmental engineering. The ideal candidate will have the ability to use word processing and spreadsheet software to compile and analyze data, andmust be a self-starter with the ability to serve independently.
This position will be serving on one of our educational programs that will be teaching environmental stewardship of the Lake Champlain Basin to 5th and 6th grade students in 4 local schools. There willbe 4 classroom sessions and 2 fieldtrips with up to 160 students (across 4 schools). Our group also presents information and water quality data at regional agricultural meetings andoutreach events (additional ~100 people).
FNLC partners with organizations to do annual river streambank clean ups, and we anticipateworking \sim 1 mile of area streams.

Prior to this year, FNLC has hosted an ECO AmeriCorps member for 6 consecutive years and wewould like to continue post-COVID.
Describe how the supervisor has adequate time and leadership experience to manage an ECO member? Please explain how:
The Projects Coordinator has over 10 years of experience managing the operations of various clinical testing laboratories, where they supervised teams as large as 20 and as small as 2. The supervisory roles required mentoring new employees and attending numerous managerial trainings.
In this role, the ECO AmeriCorps member will be serving in conjunction with the Projects Coordinator on a day-to-day basis. We will have weekly staff meetings to update the Board Chair ofongoing and upcoming activities, and we will keep in communication via email, phone, and text during unsupervised duties.
