10 V.S.A. §§ 554, 558, and 567

5. Concise summary explaining the effect of the rule. This summary will be used to provide published notice of the proposed rule. (150 words or less):

Vermont's transportation sector is the single largest contributor to greenhouse gases (GHGs) in the State. The proposed rule establishes GHG emission standards for new motor vehicles for inclusion in Vermont's Low Emission Vehicle Program. Under the proposed rule, one set of GHG standards would be established for passenger cars, small light-duty trucks, and small SUVs, and another set would be established for large light-duty trucks and large SUVS. Both sets of GHG standards would be gradually phased in between model-years 2009 and 2016. When fully implemented during model-year 2016, new motor vehicles subject to the regulation would be required to emit approximately 30 percent fewer GHGs than without the regulation.

6. Explanation of why this rule is necessary: In Vermont, motor vehicles are the greatest source of GHG emissions in Vermont. The proposed rule will lower GHG exhaust emissions from motor vehicles. Further, the proposed rule will ensure compliance with the identicality requirement set forth in section 177 of the Clean Air Act. See 42

- U.S.C. § 7507 (authorizing states to adopt motor vehicle emission standards provided that "such standards are identical to the California standards"). Moreover, Vermont's adoption of this proposed rule is part of a regional effort to reduce air pollution from motor vehicles; other northeastern states including Connecticut, Maine, Massachusetts, and New York are also moving forward with regulations to adopt California's GHG emission standards into their LEV programs.
- 7. List of people, enterprises and government entities affected by this rule: Automobile consumers, including individuals, businesses, and state and local government agencies; automobile manufacturers and dealers; the Enforcement and Air Pollution Control Divisions of the Agency of Natural Resources.
- 8. Brief summary of economic impact of this rule (150 words or less): When fully phased in with model-year 2016, it is estimated that the GHG standards will result in an average cost increase of roughly \$1,000 for vehicles subject to the rule. However, these price increases are expected to be more than offset by lower monthly operating costs due primarily to increased fuel efficiency. Assuming a fuel price of \$1.74 per gallon, the California Air Resources Board (CARB) estimated that the proposed GHG standards are expected to result in a monthly net savings of about \$3.50 to \$7.00. At higher fuel prices, the monthly savings for consumers are even greater. To estimate the proposed rule's impact on Vermont consumers, a cost analysis was conducted that assumes a fuel price of \$2.10 and a vehicle life of ten years. Vermont consumers are expected to realize a net economic benefit of roughly \$2,000 over the life of the vehicle. If gas prices increase, any economic benefit realized by Vermont consumers will also increase.
