Air Quality & Climate Division**Application for Transfer of Permit and/or Registration Ownership**

In accordance with Subchapters V, VIII, and X of the Vermont Air Pollution Control Regulations, Air Pollution Control Permits and Annual Emission Registrations are issued to the legal entity that owns and/or operates, or is otherwise responsible for the air pollution emissions from, a stationary source. When there is a change in the legally registered name and/or a transfer in ownership or operational control of such a facility where a new legal entity will now be responsible for the facility, the Air Quality & Climate Division (Agency) requires the new entity to request transfer of said Permit and Registration within thirty (30) days following the official date of transfer.

To request a change in name or the transfer of ownership of an Air Pollution Control Permit and/or Annual Emission Registration, please complete this form and submit it along with the following as applicable: 1) A written agreement containing the specific date of transfer of permit and registration responsibility, coverage, and liability, and including how annual registration data fees will be handled, between the prior and new owner, 2) the separate Certification of Information Accuracy form, and 3) the permit application fee of \$150 made payable to the "State of Vermont Air Quality & Climate Division".
