- Tier 1 and Tier 2 River and Roads trainings are a prerequisite to register for Tier 3.
- Each training module is a one-day class. No requirement to take all and/or one topic prior to the other.
- Participants are encouraged to review the "*Vermont Standard River Management Principals and Practices version 1.3*" prior to the trainings.
- Participants receive 6 hours of continuing education credits per class.
- Trainings will be held as a hybrid with in-person & Teams option.
