¹ All permit application fees are set forth in 3 V.S.A. 2822(j)(1)(A) and were last amended/effective January 1, 2018. All permit application fees are due at time of application submittal except the supplemental fees for new minor source and minor source modifications which are determined, billed and due prior to permit issuance. All permit application fees are non-refundable once submitted. The fees in effect at time of submittal of an administratively complete application shall apply for all supplemental fees for that application. In accordance with Act 77 of 2017, permit application fees for anaerobic digesters are capped at \$1,000 and no supplemental fees are assessed.





Annual Point Source Registration Fees ²		
For facilities with actual annual aggregate emissions of all air contaminants of less than 5 tons.	Select facilities may be required to register but may not be required to pay any fees. Select facilities in certain categories of sources, as to be determined by regulations, may be required to register and pay a \$500 base fee only.	
For facilities with actual annual aggregate emissions of all air contaminants of 5 tons or greater but less than 10 tons.	\$1,000 base fee, <u>plus</u> \$0.0335 per pound (\$67/ton) of emissions of SO ₂ , PM, CO, NOx, and Hydrocarbons.	
For facilities with actual annual aggregate emissions of all air contaminants of 10 tons or greater .	\$1,500 base fee, <u>plus</u> \$0.0335 per pound (\$67/ton)* of emissions of SO ₂ , PM, CO, NOx, and Hydrocarbons.	
	* For plants producing renewable energy as defined in 30 V.S.A. § 8002 the per pound fee shall not exceed \$64,000.00 on those emissions from renewable energy sources.	
Hazardous Air Contaminant Surcharge by Category of Contaminant: Fees assessed based on the total actual pounds of each contaminant emitted. Excludes emissions from combustion of fuels listed below. Hazardous Air Contaminants are categorized with regard to public health, and are as listed in App. C of the VAPCRs.	Carcinogens (Category I): \$0.95 per lb Chronic (Category II): \$0.04 per lb Irritant (Category III): \$0.02 per lb	
Hazardous Air Contaminant Surcharge by Fuel Combustion: Fees assessed based on actual amount of respective fuel burned annually.
