Groundwater Coordinating Committee Meeting Minutes

A) Talk and Discussion: Down and Out: Hydrogeology and Nitrogen Transport on Cape Cod, MA

Marcel Belaval, Hydrologist from the Water Division of EPA Region 1, graciously presented on work that has been completed evaluating nitrogen transportation by groundwater that contributes to nitrogen impairment within the bays. The primary source of the nitrogen loading is attributed to septic systems. Work was presented on three main areas of research: 1) baseline groundwater monitoring for nitrogen, CECs and other indicator parameters prior to a neighborhood sewer connection being established; 2) an assessment of permeable reactive barriers; and 3) mapping of groundwater seeps to identify sources areas within watershed to prioritize for nitrogen reduction.

B) Source Protection Collaboration between NRCS and VRWA

Diana Butler walked through the collaborative process NRCS and VRWA have been involved in to identify priority areas where NRCS can work to address source water protection challenges associated with agricultural land uses. This is in pursuit of utilizing funding from the 2018 Farm bill dedicated for source protection.

For those interested in this work, there is an upcoming meeting March 19th that will discuss this topic at the regional level – fly attached to these minutes.


