PROPOSED ACTION

The Department of Environmental Conservation intends to issue a permit renewal to the Lodge at Pinnacle View. The permittee is not required to demonstrate compliance with the Aquatic Permitting Criteria of the Indirect Discharge Rules because the treatment and disposal system is considered an existing indirect discharge as defined in §14-300 of the Indirect Discharge Rules. No significant changes are proposed for the permit renewal.

Tentative determinations regarding conditions to be included in the pending Vermont Indirect Discharge Permit have been made by the Vermont Agency of Natural Resources, Department of Environmental Conservation. The conditions imposed will assure that the Vermont Water Quality Standards and applicable provisions of 10 V.S.A. Chapter 47 will be met.
