



**Notice of Intent (NOI)**  
 for coverage under the **Pesticide General Permit (PGP)** for  
 discharges from the application of pesticides for **Small & Large Entities**

Submission of this completed NOI constitutes notice that the Entity identified in Section B intends to be authorized to discharge pollutants to waters of the State, identified in Section D, under Vermont’s Pesticide General Permit (PGP). Submission of this NOI constitutes notice that the party identified in Section B of this form has read, understands, and meets the eligibility conditions per Part 1 of the PGP; agrees to comply with all applicable terms and conditions of the permit; and understands that continued authorization under the PGP is contingent upon maintaining eligibility for coverage. To be granted coverage, all information required on this form must be completed. Please read and ensure compliance with all permit conditions, including the requirement for Large Entities to prepare a Pesticide Discharge Management Plan prior to NOI submittal, except for applications made in response to a declared pest emergency situation per Part 5 of the PGP.

**APPEALS***Renewable Energy Projects – Right to Appeal to Public Service Board*

If this decision relates to a renewable energy plant for which a certificate of public good is required under 30 V.S.A. §248, any appeal of this decision must be filed with the Vermont Public Service Board pursuant to 10 V.S.A. §8506. This section does not apply to a facility that is subject to 10 V.S.A. §1004 (dams before the Federal Energy Regulatory Commission), 10 V.S.A. §1006 (certification of hydroelectric projects) or 10 V.S.A. Chapter 43 (dams). Any appeal under this section must be filed with the clerk of the Public Service Board within 30 days of the date of this decision. *All Other Projects – Right to Appeal to Environmental Court*

Pursuant to 10 V.S.A. Chapter 220, any appeal of this decision must be filed with the clerk of the Environmental Court within 30 days of the date of the decision. The Notice of Appeal must specify the parties taking the appeal and the statutory provision under which each party claims party status; must designate the act or decision appealed from; must name the Environmental Court; and must be signed by the appellant or their attorney. In addition, the appeal must give the address or location and description of the property, project or facility with which the appeal is concerned and the name of the applicant or any permit involved in the appeal. The appellant must also serve a copy of the Notice of Appeal in accordance with Rule 5(b)(4)(B) of the Vermont Rules for Environmental Court Proceedings.
