### LICENSED DESIGNERS

## SUMMARY DESCRIPTION

A Licensed Designer is authorized to conduct site evaluations and prepare designs and applications required for Wastewater System and Potable Water Supply Permits. There are four classes of Designer Licenses:

**Class 1** – a professional engineer with a license issued to practice in the State of Vermont and who is compliant with the Designer License.

**Class A** - licensed to design water supply & wastewater systems limited to serving a single-family residence.

Class B, and Class BW – licensed to design "non-public water supplies" & wastewater systems, both limited to a design flow of 1350 gallons per day or less with various restrictions.
