COMMERCIAL AND RETAIL UNDERGROUND STORAGE TANKS

Description: Category One Tanks (COTs)	Deductible:
➤ Double walled	\$10,000
➤ Single walled, lined or unlined, release to environment discovered during routine removal of tank deductible	\$10,000 [as provided by 10 V.S.A. 59 Section 1941(a)]
➤ Single walled lined or unlined and defined as a category one tank sudden and accidental release to the environment	\$15,000
➤ Single walled lined more than 10 years and defined as a Category One Tank sudden and accidental release to the environment	\$25,000
➤ Maximum Reimbursement \$1,240,000	

RESIDENTIAL (non-rental single family home) OR FARM

Description: Category Two, Three and Four Tanks	Deductible:
➤ Motor Fuel ≤ 1,100 Gallons (Category Four Tank)	\$250
➤ Motor Fuel > 1,100 gallons (Category Two Tank)	\$10,000
➤ Heating Oil ≤ 1,100 Gallons (Category Four Tank)	\$250
➤ Heating Oil > 1,100 Gallons (Category Three Tank)	\$250
➤ Maximum Reimbursement \$990,000	

COMMERCIAL/PUBLIC BUILDING (as defined in 20 VSA §2730) HEATING OIL TANK

Description: Category Three Tanks <small>(used for heating purposes only, non-process use)</small>	Deductible:
➤ Tank less than 1100 gallons	\$250
➤ Tank more than 1100 gallons	\$10,000
➤ Maximum Reimbursement \$990,000	

ABOVEGROUND STORAGE TANKS (ASTs)

Description:	Deductible:		
➤ Commercial	\$1,000	➤ Maximum reimbursement	\$25,000
