- 1. Copy of the Certificate of Approved Location from the city/town in which the proposed salvage yard is located (original application).
- 2. Copy of Certificate of Approved Location from the city/town in which the salvage yard is located (New application only).
- 3. Location Map: either a USGS topographical map, or aerial photograph showing the site in relation to town or state roads.
- 4. Site Map showing the location of buildings, vehicle storage, vehicle dismantling, crushing, tire storage, vehicle fluid storage, fencing, gate, town roads, water bodies, neighboring water supplies and buildings within 100 feet of the property boundaries, and any changes from previous applications (renewals only).
- 5. Annual Fee:
  - □ \$1250.00- Facilities which crush or shred motor vehicles
  - □ \$750.00 Facilities which accept or dismantle junk motor vehicles (no crushing or shredding)
  - □ \$350.00 Facilities that manage junk excluding motor vehicles
  - □ \$300.00 Facilities which primarily handle total-loss vehicles from insurance companies
