Enclosed with reference to the above matter, please find our completed application with supporting map.

1.) The attached map identifies five current areas of concentrated Eurasion Milfoil harvesting. These areas border the shoreline by individual leaseholders and landowners. The Lake Carmi Camper's Association supports our harvesting efforts.

2.) We are asking for an additional area to be included to the harvesting permit; between the areas of A and E in the Sandy Bay Rd area has become infested with the Eurasion Milfoil as well and has been requested by the Lake Carmi Camper's Association to be added for the enjoyment of the lake activities and improvement of water quality.

3.) The Town will continue to mechanically harvest the Eurasion Milfoil with the equipment available to control the growth and spread of the nuisance weed. We propose to harvest from June through September with approximately 300 hrs annually to remove the milfoil from the lake.
