



**Notice of Intent (NOI)**

for coverage under the **2022 Pesticide General Permit (PGP)**  
 for discharges from the application of pesticides to waters  
 of the State of Vermont

Submission of this completed NOI constitutes notice that the Operator identified in Section B intends to be authorized to discharge pollutants to waters of the State, identified in Section C, under Vermont’s 2022 Pesticide General Permit (PGP), effective from July 15, 2022 to July 15, 2027. Submission of this NOI constitutes notice that the party identified in Section A of this form has read, understands, and meets the eligibility conditions per Part 1 of the PGP; agrees to comply with all applicable terms and conditions of the permit; and understands that continued authorization under the PGP is contingent on maintaining eligibility for coverage.

To be granted coverage, all information on this form must be completed. Except for any application made in response to a declared pest emergency, as defined in Appendix A of the PGP, any Operator who is required to submit a NOI must prepare and submit a Pesticide Discharge Management Plan at the time the NOI is filed.
