
Vermont Water Quality Standards

- Establish designated uses, management objectives, and minimum criteria that all surface waters must meet.
- Designated uses:
 - Aquatic biota and wildlife
 - Aquatic habitat
 - Swimming
 - Boating
 - Fishing
 - Aesthetic conditions
 - Public water source
 - Irrigation




Surface Water Classifications

- The classification structure for all surface waters is established by the legislature.
- Four possible classifications:
 - B(2) – Good
 - B(1) – Very Good
 - A(2) – Public Water Source
 - A(1) – Excellent
- Surface waters are classified independently for each designated use (Appendix F of the Vermont Water Quality Standards)
- All waters at or below 2,500 feet are designated Class B(2) for all uses, unless specifically designated as Class A(1), A(2), or B(1) for any use.
- All waters above 2,500 feet are A(1) for all uses unless A(2) for use as a public water source




Overview of Petitions

- Three petitions submitted by the Ripton Conservation Commission:
 - Alder Brook in Ripton and Lincoln
 - Blue Bank Brook in Ripton and Lincoln
 - Goshen Brook in Goshen, Hancock, and Ripton
- Per the Water Quality Standards, the petitions propose reclassification from B(2) to A(1) for three designated uses: aquatic biota, aquatic habitat, and aesthetics.



Reclassification Process

- The public may petition the Agency to reclassify a waterbody for any of the designated uses.
- The Agency solicits public comments on petitions received.
 - Public comment meeting was held March 30, 2021, with written comments accepted through April 9th.
 - Based on comments received, a second public comment meeting is being held this evening, with written comments accepted through October 18th.
- Pursuant to 10 V.S.A. § 1253, the Agency of Natural Resources Secretary determines whether to initiate rulemaking to reclassify, and the reaches to be reclassified, based on the technical evaluation and public comments received.
- Rulemaking for reclassifications occurs as part of the Vermont Water Quality Standards, Appendix F.
