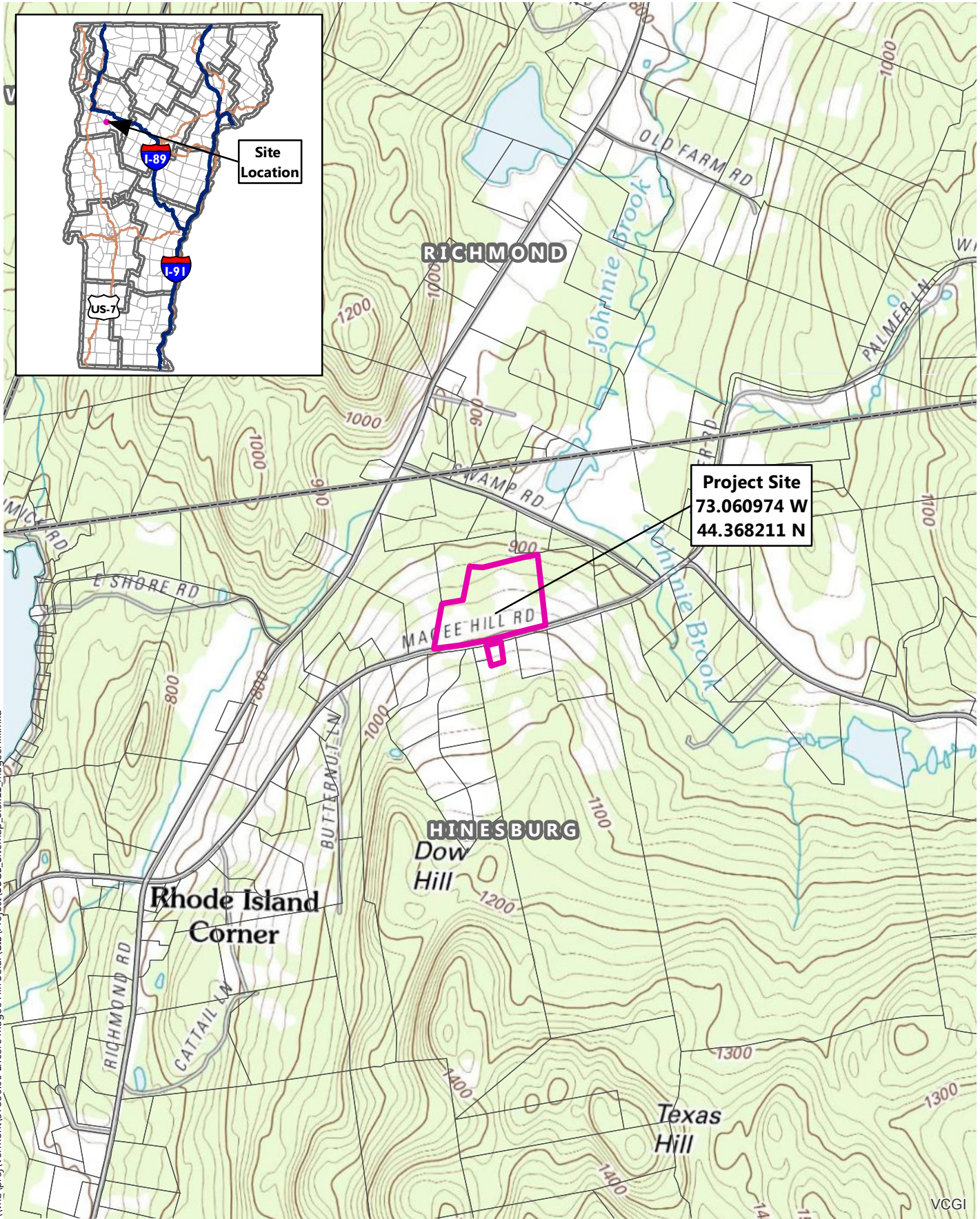

All comments received by the above date will be considered by VANR prior to issuance of an authorization under the general permit.

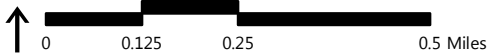
FINAL ACTION/APPEAL
