B. Findings:	
The Secretary of the Vermont Agency of Natural Resources (VT ANR) has determined that:	
1. This project authorizes excavation of accumulated sediments at Sugarbush's Mad River intake weir to maintain proper operation of	
the system.	
2. The proposed activity is eligible for coverage under the VT ANR Stream Alteration General Permit.	
3. The proposed activity will meet the terms and conditions of the General Permit provided:	
a) The project will be completed in a consistent manner with the previously held stream alteration permit SA-06-010-2016	
C. Standard Conditions:	
1. The project will not adversely affect the public safety by increasing flood hazards.	
2. The project will not significantly damage fish life or wildlife.	
3. The project will not significantly damage the rights of riparian owners.	
4. The project will not obstruct the movement of aquatic life indigenous to the waterbody beyond the actual duration of	
construction.	
5. The project is conducted in a manner which minimizes or avoids any discharge of sediment or other pollutants to surface	
waters in violation of the VT Water Quality Standards.	
6. The ANR River Management Engineer is notified by phone or email when prior to the start of construction and when the	
project is complete.	
7. Water control though the used of sandbags, gravel berms, or sediment curtains shall be used to minimize turbidity	
during construction. Use of alternate methods of water control may be used with prior authorization from the River	
Management Engineer.	
8. Removal of instream material may take place between July 1 and November 15 each year. It is anticipated that gravel	
removal will be completed concurrently with installation of the flashboards for water withdrawals at the end of October.	
9. This permit expires on 10/01/2020	
If there are any changes in the project plan or deviation in construction from the plan, the Permittee must notify the River Management Engineer immediately. If the project is constructed as you have described, as shown on the above referenced approved plans and according to	
the above conditions, there is no reason to expect any violation of Vermont Water Quality Standards.
