As the Owner or Authorized Representative, I hereby certify that, for the construction activity that was authorized under this stormwater discharge permit, land disturbing activities at the site are finished and permanent stabilization of all disturbed areas on the site through the establishment of a vigorous vegetative cover, the implementation of other approved stabilization measures, and the graveling or paving of parking areas has been accomplished. I am aware that it is unlawful under the Clean Water Act to continue to discharge stormwater from this site without a discharge permit unless these circumstances exist and that there are substantial penalties for submitting false information. I also understand that the Erosion Prevention and Sediment Control Plan and records must be held for a period of three years after project completion under the terms of the discharge permit. I further understand that the submittal of this notice does not release the Owner from liability for any violations of the discharge permit, the Vermont Water Quality Standards, or the federal Clean Water Act.




