

Notice of Intent (NOI) for Stormwater Discharges

Associated with Construction Activities on **MODERATE RISK SITES**Under Vermont Construction General Permit 3-9020

Submission of this completed Notice of Intent (NOI) constitutes notice that the entities in Section A intends to be authorized to discharge pollutants to Waters of the State, from the project identified in Section D, under Vermont's Construction General Permit (CGP). Submission of this NOI also constitutes notice that the parties identified in Section A of this form have read, understand, and meet the eligibility conditions of the CGP; have determined that the project qualifies for coverage as a Moderate Risk project in conformance with Appendix A of the CGP; agree to comply with all applicable terms and conditions of the CGP; understand that continued authorization under the CGP is contingent on maintaining eligibility for coverage; and, that the applicable practices within the authorized Erosion Prevention and Sediment Control Plans must be implemented and maintained for the duration of construction activities. In order to be granted coverage, all information required on this form must be provided and an application fee payable to the State of Vermont must be submitted.
